Sub: Filling up the post of Director of G B Pant National Institute of Himalayan Environment and Sustainable Development (GBPNIHESD) Kosi, near Almora (Uttarakhand) on deputation basis.

The G B Pant National Institute of Himalayan Environment and Sustainable Development (GBPNIHESD) Kosi, near Almora (Uttarakhand) was set up in 1988 as an autonomous organisation of the Ministry of Environment, Forest and Climate Change, Government of India to promote strategies for sustainable development of Himalayan and Shivalik ranges. The Institute undertakes research and development programmes along with the training through a network of its own centers and the existing institutions in the Himalayan region. The Director is the Principal Executive and Academic Officer of the Institute. He is responsible for the day-to-day management of activities and overall administration of the Institute.

3. The Ministry of Environment, Forest and Climate Change invites application to fill the post of Director of the G B Pant National Institute of Himalayan Environment & Sustainable Development on Deputation basis as per the Recruitment Rules of the Institute in the Pay Scale of Rs.37400 - 67000 + Grade Pay Rs. 10000/- (pre-Revised) with allowances as admissible under the Central Government rules. The eligibility conditions for the post are indicated below:-

A. Eligibility and Essential Qualifications:

Officers under the Central/ State Governments / Public Sector Undertakings/ Universities/Recognized Research Institutions or Autonomous or Semi-Government or Statutory Organisations or other Non- Government Bodies.

- (a) (i) holding analogous posts on regular basis; or
(ii) with 5 years of regular service in posts in the Pay Scale of PB: 4- Rs.37400 — 67000 + Grade Pay Rs. 8,900/- (pre-Revised)
- (b) Ph.D. degree with 15 years experience in the field of environmental research and sustainable mountain development, forestry, natural

resource management, environment in Central/State Government/research institutes of reputed Universities/public sector undertakings/reputed private companies.

- (c) Intellectual credentials with evidence of contribution to research supported by published work in reputed journals/recognized innovations and qualities of leadership for heading an organization independently

B. Desirable Qualification:

Creative, Innovative and well established scientists/technologists/foresters with three years research experience having a demonstrated ability to create an environment conducive forestry research/education/forestry extension, demonstrable capabilities for conducting independent research projects, both national and international and fund generation through such R&D activities.

C. Terms & Conditions:

- 1) The Director, GB Pant National Institute of Himalayan and Environment & Sustainable Development will normally be appointed for a period of five years or till the age of superannuation or till further orders, whichever is earlier.
- 2) The total continuous period of deputation including another ex-cadre post held preceding to this appointment in the same or other organization/department/ Central Government shall not exceed seven years.
- 3) The maximum age limit is 56 years for appointment on deputation on the last day of the receipt of application form.

D. General Instructions:

- 1) Only Indian nationals can apply.
- 2) Applications in prescribed Performa as given in Annexure-I should be sent neatly typed on A-4 size paper, along with a passport size photograph duly self-signed pasted and self attested copies of certificates of educational qualifications, experience, claim for belonging to Scheduled Caste (SC)/ Scheduled Tribe (ST).
