### Title of the Course: Nature Conservation and Livelihood

**Background:** Arunachal Pradesh is rich in biodiversity and green cover, however, most part of the state remains unexplored where connectivity and accommodation being important limiting factors. The people of the state already have the traditional knowledge in utilising the rich biodiversity of the state for food, medicine, handcrafts and handloom, house building, and other socio-cultural purposes. There is a huge potential for developing the skills of the youths to take up entrepreneurial ventures utilising the bio-resources in a sustainable manner such as in the field of agriculture, horticulture, medicinal plant cultivation, value addition of local food products. The state with its rich biodiversity, unique culture and landscape diversity, ranging from humid tropical plains to snow-clad mountains, is a great attraction for tourists. Annual Fairs and festivals, Open-air Evening Cultural programmes, traditional games& sports, handicraft, sunrise experience, etc. are some of the activities that have been the main attraction to domestic and international tourists to visit the state. The green skill development for youths would play an important role in making transition from an unsustainable and emission intensive economy to a green production and services. Realizing the demand for green skilled youth, the Green Skill Development Programme (GSDP) has been conceptualized and developed by Ministry of Environment, Forest and Climate Change (MoEF&CC). The GSDP

aims to develop green skilled workers having technical knowledge and commitment towards sustainable development.

**Eligibility:** Class 10<sup>th</sup> passed (Note: Only permanent residents of North-East Region will be eligible for this certificate course)
