Shortlisting Result for the post of Finance Officer

- Following were the details of the Qualifications that were advertised as per Advt. No. GBPI - 02/2024 for the post of Finance Officer (Level 11 as per 7th CPC):

Essential Qualifications

- i. Graduate from a recognized University with 5 years experience in Accounts services in the pay level of 7 GP 4600 or 3 years experience at GP 4800 in Govt. offices/ PSU/ Autonomous Body/ Statutory Body.
- ii. Maximum Age : 40 Years

Desirable Qualifications

- i. Post Graduate Degree in Commerce/MBA
- ii. At least ten years of relevant Experience in Government/ Government Research Establishments/ Autonomous Bodies/ Universities/ Statutory Organizations/ Government Organizations of high repute
- iii. Knowledge in Computer Applications and Office Automation, e-office, PFMS, EHRMS and Tally.
- iv. Experience in handling budget/ audit/ academic & R&D and other financial matters
- For the above post, a total of 43 candidates applied through online recruitment portal of the Institute whereas the hardcopy applications of only 32 candidates were received by the office within the due date (25 November 2024). Applications of only these 32 candidates were considered for the screening.
- Since the total applications received was large, as per the clause 3 and 6 of the general instructions of the Advt. GBPI 02/2024, the institute has adopted the following enhanced criteria for shortlisting the candidates for Interview:

b. Relevant experience in Years in Government/ Government Research Establishments/ Autonomous Bodies/ Universities/ Statutory Organizations/ Government Organizations of high repute in handling Accounts/ Finance/ Audit/ Stores & Purchase in supervisory capacity i.e., Group B (Min. Level 7 in 7th CPC or PB2 with Grade pay 4600 in 6th CPC or equivalent in IDA pattern) and above.

(6 marks for every completed years and 1.5 marks for completed quarter and a maximum of 30 marks)

- c. In 'b' above, working experience in Central Govt./Central Autonomous Bodies (CABs)/ Central Research Institutes (CRIs) for minimum 5 years – 20 marks
- d. Working experience in analogous post (pay level 11 or PB3 with GP 6600 in 6th CPC or equivalent in IDA pattern) and above for minimum one year in Central Govt./CAB/CRIs – 20 marks
- Age relaxation has been only extended to the ex-servicemen, PWD candidates and Central Government employees (Autonomous bodies, PSUs, State government agencies & institutes, etc. have not been considered) as per the existing norms. Since the post advertised is under UR category, the age relaxation is not applicable to the category candidates.

Based on the marks obtained by the candidates against the enhanced criteria tabulated above, a cut-off score of 70 marks has been finalized. A total of 13 candidates have been found eligible under the short-listing as per the above *enhanced criteria*. The short-listing cum screening result of applications for the post of Finance officer is enlisted below.
