A. Submission of Tender Document

B. Earnest Money Deposit and Security Deposit:-

- a. The bidder shall submit an Earnest Money Deposit (EMD) **@ 2.5% of the total value of the journals alongwith the bid/offer. The EMD will be submitted in the form of bank draft in favour of "The Director, G.B. Pant Institute of Himalayan Environment and Development, Kosi-Katarmal, Almora", payable at Almora.** The EMD will not carry any interest on it. The EMD will be refunded in full on receipt of request from the unsuccessful bidders after the finalization of tender. However, in case of tenders accepted for supply of foreign journals, the EMD will be refunded only after deposition of the Security Deposit by successful bidders. The successful bidders will be required to deposit Security amount @ 10% of the total value of order in the shape of fixed deposit duly marked in favour of "The Director, G.B. E. Deadline for submission of bids –

1. Bids must be received at the address specified above not later than the time and date specified in the invitation for bids.
2. GBPNIHESD may use its discretion to extend the deadline for the submission of bids by amending the bidding documents, in which case all rights and obligations of the GBPNIHESD and bidders previously subject to the deadline will thereafter be subject to the deadline as extended.

Late bids: Any bid received by the GBPNIHESD after the deadline for Submission of bids prescribed by the GBPNIHESD will be rejected and / or Returned unopened to the bidder.

F. Right to accept / reject any or all bids rest with the GBPNIHESD

1. GBPNIHESD reserves the right to accept or reject any or all bids and to annul the bidding process and reject all bids at any time prior to award of contract or supply order without thereby incurring any liability to the affected bidder or bidders or any obligations to inform the affected bidder or bidders of the grounds for the GBPNIHESD's action.
2. GBPNIHESD reserves the right to place supply order only for some of the titles of the journals required by it and also to place supply orders with different bidders for journals/periodicals required by it.

G. Placing Order - Orders will be placed to the successful bidders only when the bidder submits signed terms and conditions based on their quotations and negotiations with them.

Terms and conditions for supply of journals to GBPNIHESD Library, Kosi-Katarmal, Almora

A. Subscription -

1. GBPNIHESD does not bind itself to accept the lowest bid and also reserves the right of rejecting any or all of the tenders without assigning any reason for the same.
2. The selected Agent/Vendor upon receipt of confirm order shall process institutional subscription & make advance payment to respective publishers on behalf of GBPNIHESD Library. The Agent shall submit their Invoices within thirty days from date of order along with Remittance proof from publisher, price proof, Bank conversion certificate & Agreement.
3. All subscription must be entered in the name of GBPNIHESD Library in records of the respective publishers.
4. For all the periodicals, the Supplier shall charge the Publishers' current subscription rates as indicated in the publishers' current catalogues or invoices. Wherever concessional/ Package rates are available/ applicable, the Supplier must charge accordingly. The publisher's price proof should support the bills submitted by the Supplier.
5. Rates quoted should include all taxes.
6. Original Currency rates by publishers and converted Indian Currency rates shall be provided in the Bid.
7. The Foreign Journals available in dual currencies should be billed in the currency by which the converted cost is the lowest in Indian rupees.
8. **Subscription period:** All journals are to be renewed for the calendar year January to December or a Complete volume as specified in the order. Supply of the periodicals should commence from the issue Number 1 of the volume starting during the year unless specified otherwise.
9. **Conversion Rate** – The current bank exchange rate (TT selling rate) on the date of remittance shall be used for conversion of foreign currencies supported by a certificate issued by a scheduled bank and countersigned by the supplier. All payments will be made in Indian rupees only through account payee cheque.
10. **List of journals:** Titles to be supplied to GBPNIHESD - in the year 2018 including foreign and Indian journals which may vary from year to year.

B. Payment –

1. Upon submission of Agents Invoices along with Remittance proofs, Publishers Price Proofs, Agreement, bank conversion certificate, GBPNIHESD shall release 90% payment against the Invoice amount within three weeks from the date of submission of bills.
2. **The Payments should be released to successful vender in the ratio of 50% : 40%: and 10% on supply of Journal/Periodicals listed in the said order.**

C. On-line Activation

1. The Online journals which are available free along with print subscription should be provided by the Agent/Vendor without charging any additional service charges.

D. Delivery of Journals:

1. The Agent/ Vendor shall supply the Journals (Indian/Foreign) to GBPNIHESD, Kosi-Katarmal, Almora by Hand/ Registered/Courier Post.
2. Empanelled supplier must supply all the ordered titles, whether it is an Indian or foreign.
3. The Agent/ Vendor shall procure all the journals subscribed by the GBPNIHESD from the respective publishers by air freight arrangement at no additional cost to the GBPNIHESD and supply the same to the library. The Agent/ Vendor will ensure safe delivery of journals to the GBPNIHESD along with a Challan/ Delivery Proof in duplicate.

F. Missing issues, delay in supply and security deposit

1. The supplier shall monitor claims for missing issues of journals, if any and arrange to provide replacements within reasonable period.
2. The vendor/agent shall have to accept full responsibility for the refund in full in cases where no issue or substantial number of issues of a journal are not supplied to the Library. In case of incomplete supplies, subscription cost for missing issues must be refunded.

3. The vendor shall refund to GBPNIHESD full Amount of subscription of journals which do not start within 6 Months from receipt of payment from GBPNIHESD.
4. A Settlement Committee for missing/non-supplied issues will be conducted six months after the expiry of the calendar year for which the journal order is valid. The Agent/Vendor will be liable to refund the subscription amount along if he fails to supply missing issues or fail to refund the subscription amount equivalent to the missing issues with in the target date decided by the Settlement Committee.
