Applications are invited for the certificate course funded under "Green Skill Development Programme" (GSDP) with following details:

**Background:** Arunachal Pradesh is rich in biodiversity and green cover, however, most part of the state remains unexplored where connectivity and accommodation being important limiting factors. The people of the state already have the traditional knowledge in utilising the rich biodiversity of the state for food, medicine, handcrafts and handloom, house building, and other socio-cultural purposes. There is a huge potential for developing the skills of the youths to take up entrepreneurial ventures utilising the bio-resources in a sustainable manner such as in the field of agriculture, horticulture, medicinal plant cultivation, value addition of local food products. Agriculture is the mainstay of the people of the state along with animal husbandry and household industries including handloom and handicrafts. Since the agricultural land holdings are small and larger part of the state is hilly area with less accessibility, application of sophisticated technologies in these areas is not feasible. Moreover, the socio-economic condition of the people remains poor. Therefore, rural technologies are the suitable alternatives for enhancing agricultural production and promoting other alternative off-farm livelihood options. Moreover, these technologies can be developed at minimal cost using locally available raw materials and can be constructed by unskilled workers, thus are affordable by the poor marginal farmers/entrepreneurs. Realizing the demand for green skilled youth, the Green Skill

Development Programme (GSDP) has been conceptualized and developed by the Ministry of Environment, Forest and Climate Change (MoEF&CC), Govt. of India. The GSDP aims to develop green skilled workers having technical knowledge and commitment towards sustainable development. The proposed certificate course on “Rural technologies and Livelihood” is aimed to provide theoretical and practical knowledge in the field of rural agricultural techniques, bio-composting, fishery and poultry farming, mushroom cultivation, beekeeping, handicraft using locally available materials for enhancement of agricultural production as well as promote non-farm livelihood activities for improving the economy of rural population. This also implies to creation of green jobs which contributes to conservation or restoration of the quality of environment, simultaneously improving the social equity and overall quality of life.

**Course duration:** February 03-25, 2020 (160 hrs)

**Eligibility:** Min. 10<sup>th</sup> standard pass (however, right now the candidate should not be pursuing any regular course). School/college drop-outs may also apply.

*(Preference will be given to the candidates having experience and knowledge in Agricultural Sciences, Environmental Science, Earth Science, Life sciences, Social Science)*

**Age limit:** Maximum 40 years (Relaxation to reserved categories as per GoI rules)

**How to apply:** Interested candidates must submit the prescribed application form attached with this advertisement.
