Title of the training: Monitoring of environmental parameters: a hands-on experience

Number of seats: 5

About the training

The training will be useful for all those working or wants to work in the field of environmental monitoring including assessment of water quality/ soil quality/hydrological studies/ hydro meteorological studies/use of RS-GIS tools for environmental monitoring. It will give the intern a hands-on experience on selected topics of training. There will be only one seat in each above-mentioned area and final topic will be decided by the respective scientists. The selected interns will be attached to the scientist (s) for the duration of 2 months with whom the interns will work on specialized area under the broad category of Environmental Sciences/ Chemistry.

Course duration: 15th Feb to 15th April 2022 (2 months)

Eligibility: Candidate pursuing master's degree or in the initial phase of Ph.D. in related broad subject area are encouraged to apply for training.

Age limit: 28 years as on 15th February 2022 (Relaxation to Reserved categories as per GOI rules)

How to apply: Interested candidates must apply on the prescribed application format. The scanned copy of duly completed application form with candidate's resume must be emailed to the email id trainingvritika@gmail.com up to 20 January 2022, and selected applicant can submit the hard copy later.

Note:

- 1. Based on merit, 5 candidates will be shortlisted as interns for this training program.
- 2. All the expenses (including TA (as per GoI norms), stationery, consumables, accommodation, and food for the participating students) will be bear by the institute through the SERB funding.
- 3. Travel expenditure by shortest route will be provided up to sleeper class by train/ordinary bus.
- 4. The applicants have to produce 'a letter of authentication' from their Supervisor / Head of the Department / Head of the Institute indicating their association with the institute and "No Objection Certificate (NOC)" for allowing their student to undergo internship, if selected.
